Notice Concerning Change in Shareholder Special Benefit System

Tokyo Individualized Educational Institute, Inc. (TIEI) at the board of directors meeting held on January 31, 2014 resolved to change its shareholder special benefit system as follows.

1. Objective of change in shareholder special benefit system

TIEI's shareholder special benefit system is aimed at giving shareholders a greater understanding of the company's business to attract them by providing them with experience of the company's individualized educational services.

To further promote the above objective, the application of shareholder discount in the new "Benesse Science Class" and "Benesse Writing Class" businesses to be operated by TIEI due to business transfer starting on April 1 of this year will be added to the existing special benefit system.

Following the system change, shareholders will receive a discount on either the individual tuition fees or tuition fees for the new businesses. By extending the range of application, TIEI will make efforts to enhance the attractiveness to invest so that many shareholders will hold the company shares over a longer term.

 - No. of discount coupons: There is no change in the current number of discount coupons but new tuition fee discount rules for the new businesses will be added to the current individualized tuition fee discount rules.

- •The limit on discount coupon use per student is 3,000 yen a month and the maximum discount granted during the coupon validity period is 18,000 yen.
- •Discount coupons cannot be exchanged for cash or other items of monetary value.
- •Discount coupons can be used by the families of shareholders and their friends.

3. Period of change

The change will be effective beginning with shareholders in the register of shareholders on February 28, 2014.

The delivery of the first coupons is scheduled at the end of May 2014. After receiving the coupons and applying for the new benefit system, discount will be applied based on the above rules.
